



Declaration of Finances 2009-2010

Following United States visa regulations, Lake Superior State University can provide a Certificate of Eligibility for Non-Immigrant (F-1) Student Status (I-20) allowing you to enter the U.S. for the purpose of enrolling in a full time course of study that will lead to the attainment of a specific educational objective. Before an I-20 form can be completed, you must submit satisfactory evidence that you have adequate funds for tuition/books/fees and living expenses for one academic year. Current financial documents must accompany this form. An acceptable financial document must have been issued not more than nine (9) months before the term you attend to enroll at LSSU. The document also needs to be current within the last 90 days. Please keep copies of these documents to present to U.S. Immigration officers at your port of entry, and for your own records. To help make your financial plans, be aware that Undergraduate Bachelor's degree programs are typically 4-5 years in length. You and /or your sponsor must be prepared to meet the ongoing costs of your educational and living expenses, not only for the first 12 months, but for the entire duration of your studies.

Costs: These figures are estimates for the 2009-2010 academic year, and are subject to change. For sufficient documentation of financials, the following amounts must be verified.

- Resident Aliens & Ontario Residents living in the U.S. \$18,280 U.S. Dollars
- Ontario Residents commuting to LSSU from Canada \$10,330 U.S. Dollars
- All other International Students \$26,650 U.S. Dollars
