Provisional Certificate. The initial teaching certificate issued in Michigan upon successful completion of an approved Michigan teacher preparation program. Valid for up to 6 years during which the holder is expected to gain experience and additional training. Effective with the fall 2006 the provisional certificate can be renewed for up to 3 additional years with the completion of just 9 semester credit hours in a planned program at an approved teacher preparation institution. A second 3-year renewal requires completion of 18 semester hours in a planned program at an approved teacher preparation institution. Work toward an additional certificate endorsement or a graduate degree count as a planned program, if you hold an approved master's degree the credit requirement is waived for renewal. The 9 credits **MUST** be earned during (or at least after the issuance of) the valid lifetime of the provisional certificate.

- (1) **RACIAL** and **ETHNIC CATEGORIES** - Federal agencies require that certification recipients be reported by racial/ethnic background. In order that LSSU may meet this obligation as an equal opportunity institution, it is necessary to obtain your racial/ethnic classification.
- (2) Provide **CLEAR** copies of **ALL** Michigan Certificates issued (original provisional, renewals, additional endorsement, etc.
- (3) **OFFICIAL** transcripts will be required for all credits earned through other institutions that will be used to meet requirements for this certification. These credits must be accepted by the institution as applicable toward the certificate renewal. The official transcript(s) must be sent ATTN: LSSU Department of Education **DIRECTLY** from the other institution(s). Transcripts designated as "student copy" and official transcripts sent by the student will not be accepted. Transcripts must indicate the completion of courses satisfying the Michigan reading requirement (completed at any time), and all courses contained in the Planned Program (completed after the initial issuance of the provisional certificate)
- (4) Additional Endorsements (if any): The State of Michigan requires a person holding a Michigan teaching certificate who applies for an **additional** subject-area endorsement to complete the appropriate Michigan Test for Teaching Certification (MTTC) subject-area test(s) prior to the recommendation. Attach a signed audit sheet for the additional endorsement to add a new teachable subject to your Michigan certificate.
- (5) After we submit your recommendation to the Michigan Department of Education for processing, the State of Michigan will submit a bill to you with instructions on how and where to make payment for your certification.
- (6) Attach a signed Conviction Disclosure Form
