Important Information for Students
1. Course Rigor - The course syllabus and content are approved by the academic department at Lake Superior State University and will be taught at the college level. Therefore, you can expect the difficulty of this course to be greater than other high school courses.
2. Study Time - As a general rule, you will be expected to study two hours per week for each credit hour taken. Thus, for a three credit hour course, you should plan on approximately six hours per week for study and homework in addition to your class time.
3. Grades - You will be graded based on Lake Superior State University standards and against other Lake

4. Academic Record – The decision to pursue college level course credit should not be taken lightly. The credit and grades you earn through the concurrent enrollment program will become a part of your permanent academic record (transcript) at Lake Superior State University. Your academic record at one institution will follow you to all subsequent institutions. Poor performance (a grade below a "C" or 2.000) may cause a student to be placed

Superior State University students. You may be required to take departmental exams, as well as a final exam

upon completion of the course. This exam will be administered at your high school.

on academic probation. Students placed on academic probation may find it difficult to enter another college or university and may not be eligible for financial aid. **Students placed on academic probation will receive a letter from LSSU indicating their probationary status.** Students must be in Good Standing (cumulative gpa of 2.000 or higher) at LSSU to be eligible for continued enrollment. Students on academic probation are limited to course repeats, if available.

- 5. Policies/Procedures You will be expected to follow Lake Superior State University policies and procedures. To view the Lake Superior State University Undergraduate catalog visit http://www.lssu.edu/catalog/.
- 6. Attendance **Successful students attend all classes.** It is up to each LSSU professor to state in his/her course syllabi what will be the professor's expectation for class attendance and the professor's excused absence policy. When an absence cannot be avoided, it is the student's responsibility to contact his/her professor as soon as possible in order to explain the situation and circumstances to the professor.
- 7. Drop Date- If you have not earned a C (2.0) or higher grade prior to **March 22, 2019**, you should contact your high school counselor and LSSU's Concurrent Enrollment Coordinator as soon as possible. If you drop a course before the drop date, you will be assigned an "N" grade for the course and will not receive college credit for the course. A grade of "N" does not impact your gpa. Students remaining in the course, after the drop date, will be assigned a final grade (A-F) based on their course performance. Please make sure you talk to your instructor/counselor before the drop date to check your grade.
