MID YEAR PROGRESS MONITORING

Public Acts 147, 148, and 149 were signed into law in August 2020. This legislation requires that K-8 students be assessed by a state approved benchmark assessment within the first 9 weeks of school and again by the end of the school year. Although legislation does not specifically state the administration of a winter assessment, academies are required to report out on progress towards plan goals by February; therefore, without being specifically stated, schools must administer the assessment in January in order to have this data. Are you confused yet?! The good news is that LSSU CSO will create the report that meets this requirement as long as winter NWEA testing is completed by January 22, 2021. Remember, legislation requires that student progress towards the mid year goal must be posted on your academy website by February 1, 2021. We understand that this speeds up winter testing and that there may or may not be the recommended minimum of 9-10 weeks between fall and winter test administration but it cannot be helped. Our typical winter test window opens in early January and runs through February, however, this just wasn't possible due to the legislation. You should have all received notification on this long before holiday break via email/memo from our office. Please contact me if you have any questions and thank you so much for being YOU.

MIDATA HUB

Recently, I met with Tim Davis, Relations Manager for the Michigan Data Hub. I learned that all academies and schools in Michigan are encouraged to join the MiDataHub in order to streamline the upload process for required benchmark assessment data. Academies are required to report mid year and end of year progress towards learning goals outlined in the Return to Learn legislation. Data upload may also be performed manually but is a bit more intensive.

This data must be uploaded by June 30, 2021. The good news is that this service is FREE. What is MiDataHub?

The Michigan Data Hub is a collaborative statewide effort to address challenges in managing and using school data. The MiDataHub initiative focuses on creating ecosystems where information is exchanged between the large number of disconnected data systems used in schools. Mr. Tim Davis will present at the LSSU academy leader meeting scheduled for January 21st at 10 a.m. The meeting will also be recorded for those of you that are unable to attend the live session.
