**Scholarships are subject to change. Institutional scholarships and grants cannot exceed the cost of tuition and room and board, if recipient lives on campus. Awards are subject to federal and state eligibility. Scholarships are renewable for up to four years of full-time continuous enrollment, if renewal requirements are met. A new freshman student who meets the criteria for a scholarship will receive a letter of notification regarding the scholarship.*

TRANSFER MERIT

No more than two consecutive years' break in postsecondary enrollment.

LAKER GOLD COMPETITION\$2,000 - full ride/yr

High school seniors with a minimum 3.5 GPA will be invited by LSSU to compete for:

- **Laker Premium** (1): full tuition (12-16 credits) + base-rate room & board
- **Laker Gold** (1): full tuition (12-16 credits)
- **Laker Silver** (3): \$3,500
- **Laker Bronze** (3): \$2,000

SEN. PHILIP A. HART SCHOLARSHIP Full tuition/yr

Must be a Michigan high school or college graduate with a minimum 3.0 GPA. Student will be required to apply.

Deadlines apply. ... Renewable.

ALUMNI LEGACY AWARD\$2,000/yr

Must be a child or stepchild of an LSSU alumnus and entering as a freshman. Reported on LSSU application.

Must submit certification form. ... Non-renewable.

ANCHOR AWARD\$2,000/yr

Awarded to students from the following Michigan counties: Alcona, Alger, Alpena, Antrim, Benzie, Charlevoix, Cheboygan, Chippewa, Clare, Crawford, Delta, Dickinson, Emmet, Gladwin, Grand Traverse, Iosco, Kalkaska, Keewenaw, Leelanau, Luce, Mackinac, Marquette, Menominee, Missaukee, Montmorency, Ogemaw, Oscoda, Otsego, Presque Isle, Roscommon, Schoolcraft, or Wexford.

FAFSA required. ... Must live on campus. ... Renewable for one year only.

LAKER GRANT\$2,000/yr

Awarded to new first-time students and transfer students.

FAFSA required. ... Must live on campus. ... Renewable for one year only. ... Restrictions may apply.

CONTINUING AWARD\$1,000/yr

Awarded to re-admitted students with an LSSU GPA of 2.5 or higher and to transfer students with 1-11 earned credits.

FAFSA required. ... Renewable for one year only.

PHI THETA KAPPA SCHOLARSHIP\$1,000/yr

Members transfer directly to LSSU with a minimum 3.5 cumulative transfer GPA.

Must submit proof of membership.

One-Rate Tuition

LSSU's One-Rate Tuition guarantees that everyone pays our in-state rate.

LSSU operates on a "tuition plateau" plan. This means that students can enroll in 12-16 credits per semester for one flat rate of \$6,420.

Fewer or more credits are charged at a rate of \$535 per credit.

These are estimated figures and can change. Rates are established annually by the LSSU Board of Trustees.
