#### ACADEMIC REPORTS TO BE PUBLISHED

LSSU CSO was happy to lighten the load of administrators and assist with creating the transparency reports required under "Return to Learn." We published both a midyear report to meet the transparency requirement deadline of February 1 and an end of the year report with a deadline of June 30, 2021 for each of our academies. In addition, LSSU CSO will publish annual academy reports that align with educational goals. 2020-21 Annual Academy Reports will be completed by late summer/early fall. Yes, we realize that is has been a pandemic year, however feel it is important to establish (to the best of our abilities) some baseline data. We are aware that this data may not include all students tested, that testing conditions may have not been the most conducive to learning, virtual/in person instruction as well as numerous other factors to consider that impact results. Testing results will not be used for accountability purposes but rather roughly gauge where students are. As an authorizer, in the end, we felt it was important to collect the data we did have. 

#### TIERING AND SUPPORT IN 2021-22

LSSU CSO is moving towards a new system of identifying academies that are at risk for not meeting contractual goals. This is not meant to be punitive in nature but rather allow us, as your authorizer, to provide needed support that increases the probability of student and academy success. Academies will be identified for support in any of the following categories: finance, governance and compliance, academics, or whole child identifiers. Academies will be identified for support in late July (timeline may be adjusted due to when data becomes available), complete a plan of action in August, implement the plan in September through June, and evaluate the success of the plan in July. #### **READ BY GRADE 3 UPDATE**

The Senate Education Committee moved two bills in a 4-2 party-line vote to pause the controversial "Read by Grade 3 Law" but will restart and expand the law in the 2021-22 school year. The "Read by Grade Three" law was passed in 2016 and requires third graders who scored a 1252 or below to be retained and, in 2021-22, will expand to include 4th graders.

Former State Superintendent Michael Rice stated, "third grade retentions are bad public policy, and even more so if expanding students in two grades." To learn more, please visit,

#### STAFF RECIPE

#### COWBOY CAVIAR

- 1/2 cup olive oil
- 1/4 cup granulated sugar
- 1/4 cup white wine vinegar
- 1 teaspoon chili powder
- 1 teaspoon salt
- 1 pound Roma tomatoes
- 1 (150x) can of black -eyed peas drained and rinsed
- 1 can (15 oz) can of black beans
- 11 ounces sweet corn
- 1 red onion diced
- 1 green bell pepper diced
- 1 red bell pepper diced
- 1 cup fresh cilantro chopped

In a large bowl, whisk together the oil, sugar, vinegar, chili powder, and salt.

Add tomatoes, black-eyed peas, beans, corn, onion, and bell peppers. Stir to combine. Stir in cilantro. Cover and chill until serving time. Serve with tortilla chips.
