



#### **Homemade Alfredo Sauce**

#### **Ingredients**

- 1/2 cup butter
- 11/2 cups heavy whipping cream or half and half
- 2 teaspoons minced garlic
- 1/2 teaspoon Italian seasoning
- 1/2 teaspoon salt
- 1/4 teaspoon pepper
- 2 cups freshly grated parmesan cheese
