Articulation Agreement Between Sault Area Career Center and Lake Superior State University

This affiliation agreement is intended to set forth guidelines for the working relationship that will exist between Lake Superior State University and Sault Area Career Center. These guidelines relate to the granting of college credits for medical terminology, and first aid/CPR course work accomplished at Sault Area Career Center.

Both contracting parties, desirous of cooperating to enhance student preparedness for nursing education, and promote students selecting health professions as a career option, accept the following agreement:

The medical terminology course work will include basic medical terminology related to all areas of health care, the focus being on understanding and proper usage of medical language. After successful completion of this course work, the student will be able to:

- 1. Describe the origin of medical terminology
- 2. Match premixes, suffixes, and root words with their meaning
- 3. Divide basic medical terms into their component parts
- 4. Define medical terms by analysis of those terms
- 5. Spell medical terms accurately
- 6. Correctly use medical terminology in communication of information

Competency of these objectives will be measured by unit tests and the same comprehensive final examination given by LSSU course instructor that must be passed with a 70% or above to be administered by the Career Center instructor.

The first aid and CPR course work will meet current Red Cross standards. Students will be required to complete the course work at an acceptable standard to be awarded a Red Cross certification in First Aid and CPR.

Upon successful completions of this course work the student will be awarded a certificate of completion signed and dated by the instructor (see attached). Three college credits from Lake Superior State University will be awarded to the student who enrolls in classes at Lake Superior State University and presents this signed certificate to the registrar's office.
