## APPLICATION FOR AUDITING A COURSE

An individual may register for courses on an audit basis provided space is available and all prerequisites have either been satisfied or waived with the permission of the instructor. Individuals auditing a course shall be entitled to full classroom participation, and may complete all assignments and examinations for evaluation by the instructor, although these are not required for auditors. **Not all courses can be taken for audit, and permission of the instructor (or Dean) is required prior to registration.** Courses numbered below 100 may not be audited.

Individuals auditing a course will receive a final mark of AU (Audit) recorded on their LSSU academic transcript but will NOT receive university credit for the course.

Auditing courses does not count as part of an individual's official class load for determining financial aid eligibility, veteran's benefits or any other enrollment certification requirements. Students may change from an audit to credit status during the first week of classes and only with the concurrence of the faculty member for the course. This change must be processed through the Registrar's Office for grading purposes. Requests for course audits will be processed **beginning two weeks after the start of registration** to ensure degree-seeking students have adequate opportunity to enroll prior to course auditors.
