Introduction

I wish to thank our current Interim President, Dr. Gillette, the Lake Superior State University Board of Trustees, Dean Berchem, my psychology colleague Dr. Olson-Pupek, and the Chair of the School of Kinesiology and Behavioral Science, Dr. Joe Susi, for providing and supporting my year long sabbatical which enabled me to complete a number of scholarly projects.

The primary goal of the sabbatical year was to complete and submit multiple student-related projects for publication in professional journals and edited books. Another goal was to complete a book on international health care and ethical issues associated with COVID-19 (at the time of the sabbatical application, this book was under contract). The student-related projects, in particular, had not been completed for publication because of the time demands of teaching, advising and committee service.

Although I deliberately left the Sault Sainte Marie area so I could focus on writing, I did maintain contact with multiple students whom I advised and also provided letters of recommendation for graduate school and employment during the sabbatical period. I also participated in several professional conferences and continuing education programs during this time. Finally, I was involved in several work groups/task forces through the American Psychological Association addressing issues with First Generation University Students as well as with COVID-19. I also was a member of a Lake State Psychology faculty search committee.

I will describe each of these activities in greater detail below.

Books Completed

Description

The book on international issues with COVID -19 published in May, 2023 was based on work with a group of colleagues who were part of a task force on "Legal and Ethical Issues in COVID -19" under the auspices of Division 52 (International Psychology) of the American Psychological Association.

I also completed two other book manuscripts. One of these, which was not part of the original sabbatical request, is under contract with Cambridge Scholars Publishers. The book addresses ethical issues arising during COVID that were not thoroughly addressed in the earlier published volume. The topics included in this second book include moral injury, ethics of conspiracy theories, ethical cost-benefit analyses of school closures, social distancing, restrictions that disrupted the international economy, ethics of surveillance, and implications for future pandemics.

The third manuscript is a scholarly treatment of current issues in higher education assessment. The manuscript places assessment in the context of current social, economic, and political issues in higher education (student retention, pre-college academic preparation, accreditation, government oversight). In addition, the manuscript critically evaluates the rigor, including reliability and validity, of current assessment approaches. The manuscript includes descriptions of assessment projects that I have conducted at Lake State that have been previously published and presented at conferences.

Journal Articles and Book Chapters in Edited Books

Description

I had several student research projects that I thought were of sufficient quality and significance to warrant publication if they were re-written in journal or book chapter format. Nearly all of those projects were completed and published (See Cornell, Bouwens, Thompson & Beard below) during the sabbatical period. One of these papers is still under review by a journal (See Armock below)

A collaboratively-generated book chapter, "The Impact of a Positive Psychology Course on Students' Lives: Results from a Collaborative Assessment," based on students' written journal entries, was published. This chapter, along with several published articles that I have coauthored describe alternative, qualitative assessment of university student learning and instructor teaching practices.

I also completed several other articles and book chapters that were not part of the original sabbatical request (See Rami, Searight, et al; and the four chapters in the Springer Encyclopedia series).

Late in the sabbatical year, I was asked to contribute to two upcoming edited books addressing issues in the teaching of undergraduate psychology. One of these manuscripts has been completed. One of the chapters focusing on the ethics of "Therapeutic Lying" includes an assessment component which was recently approved by the Institutional Review Board.
