# Charter Schools Office and Academy Highlights

The mission of the LSSU Charter Schools Office is *to ensure quality oversight and support to our authorized charter academies, resulting in students who are prepared for the next phase of life, whether it be attending college or entering the workforce.* We are proud of our academy's commitment to their students and the broader community. Below is some of the great work happening to help fulfill this mission.

## LSSU Charter Schools Office Highlights

### **Concurrent Enrollment Fall 2025**

*PSYC 155 Lifespan Development* is at capacity, and students are underway with their learning under the instruction of Dr. Russell Searight.

### **Second Annual July Leadership Summit**

Over 100 charter academy administrators convened in Bay City, MI, on July 22–23, 2025, for two days of collaboration and professional learning. Feedback data affirmed both the immediate impact on leadership practices and the ongoing refinement of this annual summit.

### **GLSW Charter School Exclusive Recruitment Event**

We are finalizing registrations for this event and anticipate participation from seven of our eight high school academies. We are optimistic that this event will encourage future university enrollment, strengthen institutional partnerships, and help reduce barriers between our academies and the campus community. We are grateful to our university colleagues for their collaboration and support in this work.

### **2025-26 Targeted Professional Learning for Academy Leaders and Staff**

We are offering twelve professional learning opportunities for all academies and two targeted supports for MDE classified partnership districts. Fifty participants are registered for Fall 2025 offerings.

### **2025-26 Board Professional Development**

Angie Irwin of AirWin Educational Services, LLC will lead a nine-part virtual training series with three in-person sessions during 2025–26, engaging new and experienced board members in charter school history, board responsibilities, and stakeholder relationships. Participants will gain practical resources, enabling legislation, clearer role understanding, and governance best practices.

## *Growth Plan Highlight:*

- Administrators meet monthly with Athena Gardner, Partner Liaison from the MDE Office of Partnership Districts and Natalie Turner, Educational Improvement Consultant from Wayne RESA. Detroit Service Learning School District is proud to report they have met their academic growth goal and it is anticipated they will be released from Partnership this coming Fall. The measures implemented to support Oak Park students have been implemented at all sites resulting in student academic gains districtwide.
- As one of LSSUs initial charter academies, Detroit Service Learning District (DSL) is committed to their partnership with LSSU and is fully committed to the professional learning opportunities and support provided by the LSSU Charter Schools Office. DSL has had staff representation at all 2024-25 Professional Development provided by LSSU and is registered for 2025-26 Professional Development Offerings focused on enhancing leadership capacity.
- Reflecting the Statewide teacher shortage, 70% of their instructional staff are non-certified instructors functioning in a teacher-of-record capacity. We are offering support by providing instructional professional development aimed at building teacher capacity and strengthening instructional quality. This aligns with AIA's goal set by the Office of Partnership Districts of Administrators focusing on strengthening feedback provided to instructional staff and aligning professional learning with instructional cycles.

### *Academic Highlights:*

- Across all campuses, ELA M-STEP proficiency increased between 2–5 percentage points from 2024 to 2025, with all schools showing gains. Mean PSAT8 composite scores also rose at each site, with increases ranging from 18 to 43 points, reflecting steady academic growth.
- DSLA completed the Summer Discovery Program which provides robust and targeted support for all students with tiered learning opportunities for Honors, Special Needs, and Credit Recovery populations.

### *Additional Highlights:*

- Summer Discovery Program: A five week summer program provided at all three of DSLA sites. This program is funded by United Way of Southeastern Michigan. According to the Summer Discovery Coordinator Mrs. Nwankwo: *This program is more than just summer school—it's a launchpad for success. We're preparing students academically, socially, and emotionally, while giving them experiences that build confidence and curiosity.* The program includes academic support, enrichment activities, Friday field trips, and an option for a paid internship for 8th grade students.
- Oak Park Learning Academy Campus is celebrating the opening of a brand new gym just in time for the 2025-26 school year.
- 2025-26 initiated the Walking School Bus Program. This innovative project was designed in collaboration with local law enforcement to build safe, connected communities. This program gives families peace of mind with parent and volunteer guides leading children along safe walking routes to and from school each day supervised by drone coverage.

We are offering support by providing instructional professional development aimed at building teacher capacity and strengthening instructional quality. This aligns with AIA's goal set by the Office of Partnership Districts of Administrators focusing on strengthening feedback provided to instructional staff and aligning professional learning with instructional cycles.
- AIA is striving to ensure the implementation and use of a detailed curriculum to improve student outcomes. To support this, LSSU CSO is providing targeted coaching from an NWEA data coach.
- Student math skill gaps are of significant concern, and AIA is committed to working with Wayne RESA content area consultants to review student data and create an instructional plan for the 2025-2026 school year.

*Academic Highlights:*

- AIA has a Graduation Rate Index of 82%.
- PSAT mean composite increased 8%.
- PSAT median scores for cohort students (3+ year students) is 730, while the median for non-cohort students is 715.

*Additional Highlights:*

- AIA High School has a thriving cosmetology program.
- AIA is proud of their amazing robotics team which attended the LSSU Robotics Competition.
- AIA Esports team was new for the 2024-25 school year and proudly reports they made the playoffs!

### *Student Highlight:*

#### ***Inkster Student Excels in Biomedical Research Program at Wayne State University***



Congratulations goes out to Lyric Travis, a senior at American International Academy in the City of Inkster, Michigan, and a life science researcher in Ecotek Lab. Lyric recently completed her second year of hands-on research in cell biology at Wayne State University. This summer she worked with researchers in the Mott Center Human Growth and Development-Perinatology Research facility to examine the impact of stress on human embryo development. Lyric presented her work at the 2025 BCAP Research Symposium on August 18. She is the only student in the City of Inkster to secure a paid biomedical research position in the BCAP Program this summer. As a result of her commitment, Lyric has qualified to participate in the 2026 Michigan Regional Junior Science Symposium and the 2026 M2P2 Program. She also has an opportunity to work as a co-op student during the current school year at Gennex, a genetics startup research company.

- ATA hosted a 25th Anniversary Celebration August 21-22, 2025!
- ATA has a thriving Workforce Development Program which includes multiple opportunities in Career and Technical Education and Early Middle College. Certified Career and Technological programs include programs in business, engineering, computer science, and healthcare. In partnership with Southwest Detroit Apprenticeships and Trades, programming in HVAC, CNC, Electrical, Plumbing, and Cosmetology are available to students. Early middle college opportunities include, Medical Assistant, Pharmacy Tech, and Cyber Security.
- ATA Athletics offers many opportunities for student athletes including football, volleyball, basketball, cross country, and soccer.
- The LSSU CSO has recently employed an ATA graduate as a student worker for the 2025-26 school year.

### Interaction Details

**Student interactions: Total ~565** (includes student count for multiple visits)

- July 2024, Regent Park Scholars Summer School: **65 students**; ~12 adults; 5 programs
- Academic year 2024-25:
  - Bay City Academy school visit and field trip (10<sup>th</sup> grade to Bay City State Park): **290 student interactions**, ~7 adults, 11 programs for grades K, 1, 3, 4, 7, 8, 9, 10, 11, 12
  - LSSU Campus visits: **~211 students**; 36 adults; 6 schools; 6 programs

### Notes:

- Two new school programs were developed to take on the road to Bay City Academy (Spring 2025).
  - A custom field trip experience for 10<sup>th</sup> grade students allowed them to connect with their place in the Great Lakes watershed by studying wetland, beach, and woodland ecology at Bay City State Park.
  - A new program to map physical properties of local river systems was developed to use with Bay City Academy seniors. This program will be modified for use with schools in other locations.
- One new program was developed for LSSU spring campus visits.
  - A new “cultural connections” program was developed to introduce Ridge Park students to indigenous history and culture as communicated through displays and information in the CFRE Great Lakes Discovery Center (GLDC). This program will be used for other school visits to the GLDC.

### Teacher planning and school support:

- Beth Christiansen and Tammy Bell collaborated on a professional development curriculum plan for charter school teachers to connect to their place in the Great Lakes system through field experiences and expert interactions. During and after PD, participating teachers would prepare and facilitate similar learning opportunities for their students with coaching and teaching support from Beth throughout the academic year. The PD was not implemented in summer 2025 but is intended to be pursued in summer 2026.
- Liz Shea (BCA secondary science teacher) worked in partnership with Beth Christiansen to design a field trip to Bay City State Park to support tenth grade ecology studies in 2025 and into the future.

- Beth Christiansen presented to five members of Bay City Academy's board of directors during their planning meeting at LSSU.

#### **LSSU Recruitment Efforts:**

- Beth Christiansen has interacted with approximately 355 secondary students during school visits and LSSU campus visits, to provide information about LSSU opportunities in addition to programming focused on freshwater stewardship.
- CFRE is participating in developing a recruitment event for charter school students scheduled for October 23-24, 2025. CFRE's education and outreach team will lead an afternoon of natural resources-based field experiences for visiting students during Great Lakes State weekend.

#### **LSSU undergraduate student support:**

Seven different LSSU CFRE undergraduate employees supported the October, May and June campus visits. They built skills to share knowledge gained through LSSU courses to facilitate experiential learning for elementary through high school students. These student employees are true ambassadors for LSSU and represent what it means to be a Laker.

#### **CFRE staff support:**

In addition to Beth Christiansen, support for developing and facilitating programs was provided by Michelle Visser (Great Lakes Outreach and Education specialist) and schedule coordination by Sandy Taylor (Executive Assistant & Outreach Coordinator).
