#### Background:

1. The Academic Progress Rate (APR) Report is an assessment of academic success of student-athletes that accounts for the eligibility and retention of student-athletes.
2. APR improvement plans are required for all teams with a multi-year APR below the 930 benchmark.
3. The Academic Progress Rate (APR) Report was submitted to the NCAA on October 8, 2024, for Division I Men's Ice Hockey. The single year APR score for LSSU was 1000.

#### Purpose:

To provide an update of conference players of the week and other notable award recipients since September 19, 2025.



CCHA Rookie of the Week (10/6/25) – Calem Mangone (Sault Ste. Marie, ON, Canada), led all rookies in NCAA Division I Men's Ice Hockey in goals scored during opening weekend at Stonehill. His four points were second-most of any player in the nation. He scored three goals in the sweep, was a +4, and scored a powerplay goal and game-winning goal.



CCHA Defenseman of the Week (10/13/25) – Adam Barone (Sault Ste. Marie, ON, Canada) led all CCHA defensemen with three points in the home opening weekend against Lindenwood. The sophomore also blocked three shots and registered three shots on goal.



Men's Ice Hockey: CCHA Forward of the Week (11/3/25) – William Ahlrik (Tidaholm, Sweden) registered five points on the weekend vs St. Lawrence and Clarkson to lead all scorers in NCAA Division I Men's Ice Hockey. The sophomore finished second nationally in faceoff percentage for the weekend and has now won 50% or more of his faceoffs in seven of eight official contests this season.
